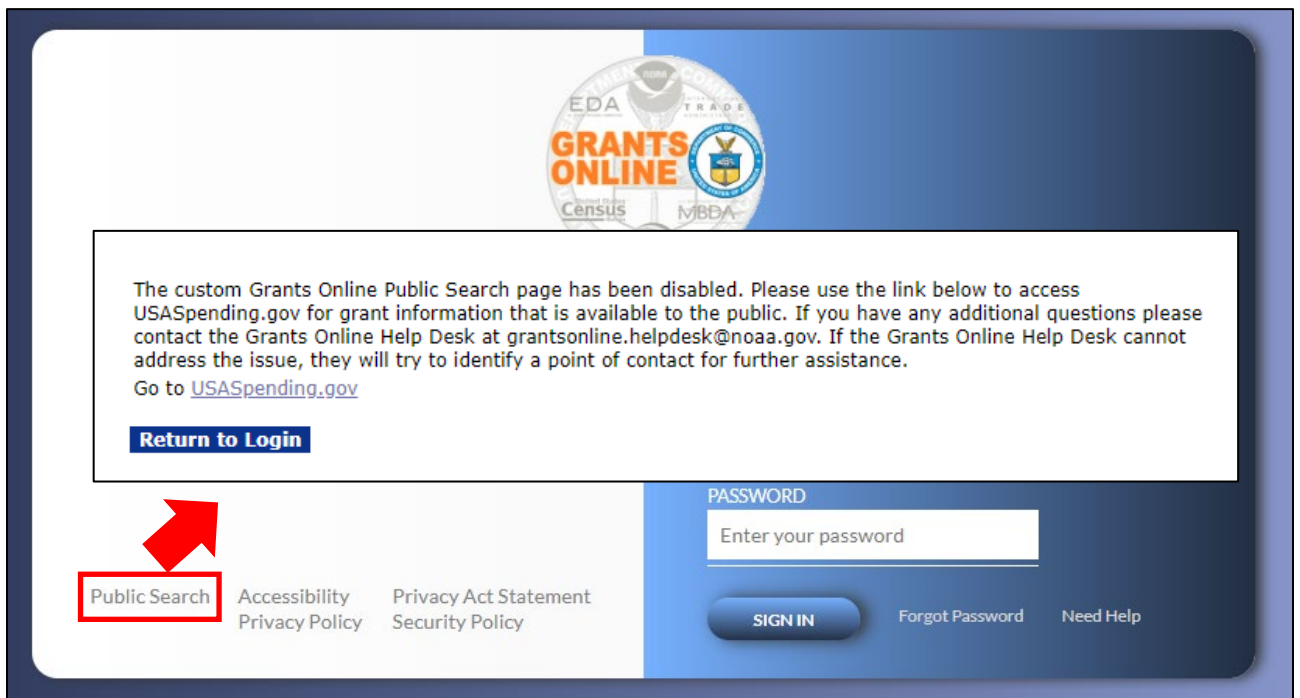

4. Periodically, some links within Grants Online do not navigate to the correct external file on the Grants Online PMO website. When the Grants Online PMO website transitioned to the noaa.gov domain, occasional patches or updates have impacted the functionality of our website. We are closely monitoring links from within Grants Online as well as the Grants Online PMO website and will address broken links in a timely manner. [JIRA: GOL-1104]
5. When a FPO initially added a new organization, the Commercial and Government Entity (CAGE) Code was not being saved. This issue has been fixed. [JIRA: GOL-1107]
6. When attempting to log in to Grants Online, sometimes the user experiences a blank screen after entering the userid and password. The current workaround is to use a different browser window. 7. The Public Search link on the Grants Online login page will now give instruction to the user to visit the USASpending.gov website. [JIRA: GOL-1131]

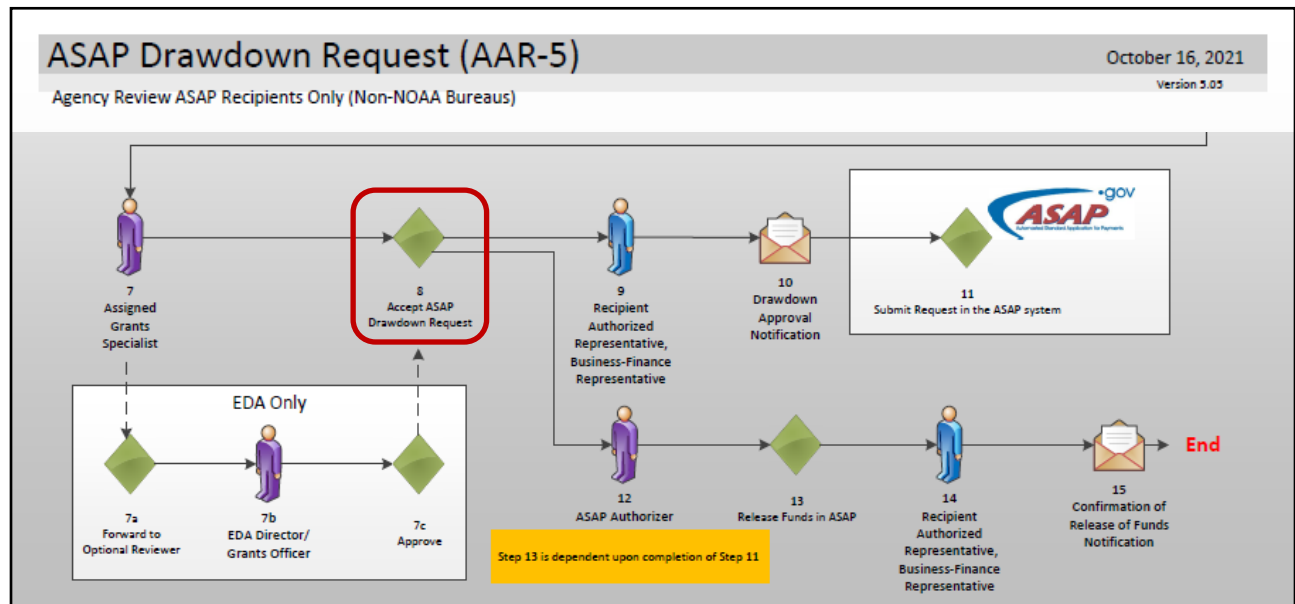

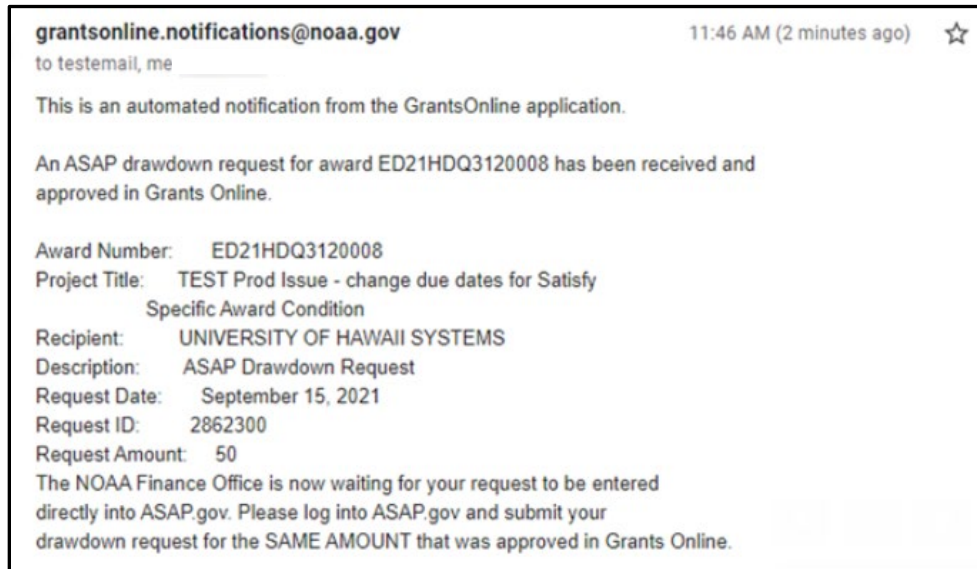

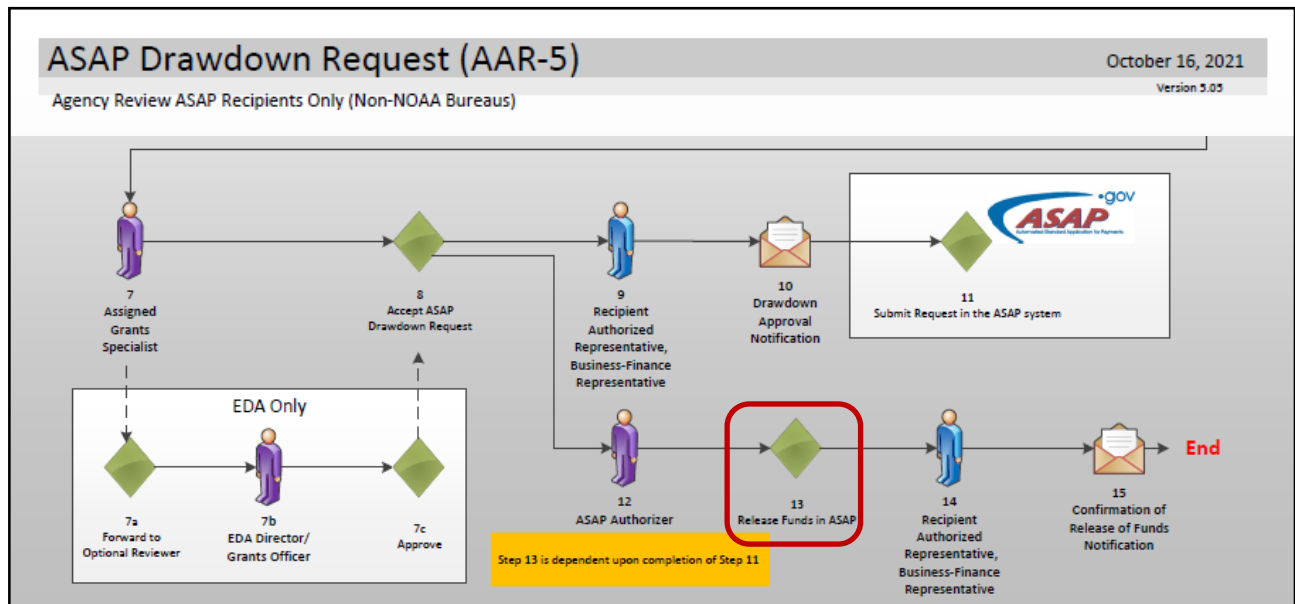
- The AAR-5 process map and the email sent to the users involved in the ASAP drawdown request process have been updated. [JIRA: GOL-1112]

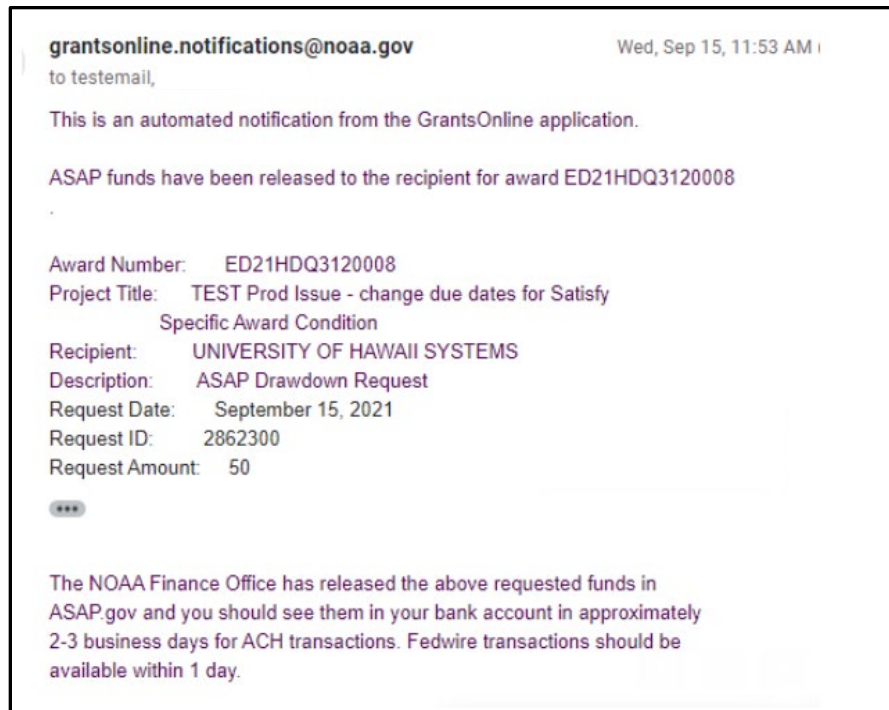
Sample email notification sent to the Recipient Authorized Representative and the Business-Finance Representative. (AAR-5, Step 10)
