Hi Bill and Julie,

Thanks for your email! Yes, we at NMFS are conducting an economic analysis of our critical habitat designations. However, our process is slightly different than FWS, and we are slightly behind FWS. Here is a short summary of our plan and progress:

As you know, NMFS has jurisdiction over sea turtles when they are in the water. At present, we are in the process of identifying and mapping marine areas that contain features essential to green sea turtles. Once we have maps to share, we will review the INRMPs (thank you, for sending those!) for DoD installations that overlap with potential critical habitat. At that point, I will get back in touch with you to discuss those INRMPs. After our discussions on the INRMPs, we would ask you about national security impacts. If the designation of critical habitat may result in additional financial costs, our contractor (Industrial Economics) would also ask you about economic impacts.

We are going through this process for all 6 DPSs within US jurisdiction. I started with the South Pacific (American Samoa...I do not believe that we have any overlap with DoD installations there). Next, I will work on the East Pacific (i.e., California), which will be followed by the West Pacific (i.e., Guam and CNMI). I am hoping that we will be back in touch with you by the end of summer to discuss the Joint Region Marianas INRMP (and Andersen Green Sea Turtle Management Plan).

Please let me know if you have any questions or concerns. Hope all is well with you!

Hello,

My name is Ann Marie Lauritsen and I work for the Fish and Wildlife Service. Together with National Marine Fisheries Service, we are starting the critical habitat designation process for green sea turtles (we just proposed 11 DPSs for listing under the Endangered Species Act). Under the Endangered Species Act, the Services do not designate critical habitat on DoD areas where we conclude that an INRMP provides a benefit to the species.

(B)(i) The Secretary shall not designate as critical habitat any lands or other geographical areas owned or controlled by the Department of Defense, or designated for its use, that are subject to an integrated natural resources management plan prepared under section 101 of the Sikes Act (16 U.S.C. 670a), if the Secretary determines in writing that such plan provides a benefit to the species for which critical habitat is proposed for

designation (16 U.S.C. 1533(a)(3)(B)(i).

We have identified green turtle nesting beaches on Andersen AFB, Naval Base Guam, military leased lands on Tinian in CNMI, and Pacific Missile Range Facility in Hawaii as follows:

On CNMI: Military Leased Lands on Tinian: Chula, Babui, Lam Lam, Chigit, Dangkulo, Masalok Naval Base Guam- Dadi, Spanish Steps, Haputo Anderson Air Force Base- Terague Basin (Terague, Scout, Sirena, Pati, and EOD)
Kaua'i, Hawaii- Pacific Missile Range Facility

Attached is our recommendation for best management practices that may be incorporated in the INRMPs. These best management practices, when implemented, provide a benefit to nesting and basking green turtles. Please contact me to discuss the timing and specifics of incorporating these recommendations in the INRMPs prior to the proposed rule being published. Is there is anyone else in the Navy or AF that I need to contact on this request?

NOTE: The basking conditions will only be applicable for the Pacific Missile Range facility on Kaua'i.
