Subject: 45 SW Integrated Natural Resources Management Plan Annual Review

In accordance with Air Force Instruction (AFI) 32-7064, Integrated Natural Resources Management, an annual review of the 45 SW INRMP is required in coordination with USFWS, NMFS and FWC. The 45 SW INRMP was signed in September 2016, therefore we are approaching the required annual review period. This email serves to request your availability to meet either in person or by phone to perform the required annual review. This meeting will document agency feedback, concerns, and/or areas of concern for improvement for INRMP implementation and management that may be integrated into the final 2016 update. Additionally, 45 SW staff will review proposed changes to the INRMP for 2016 as well as review the implementation table of work performed the prior year.

Please respond to this email by 15 August indicating your desire to participate in a meeting, either in person or via telecom, along with dates of availability. These meetings must be conducted prior to the end of August in order for the 45 SW to meet the required annual review deadline in September.

If unable to attend a meeting please indicate if your agency will be able to perform this review via email documentation; please note a signature by your agency will be required on the 45 SW INRMP 2016 Annual Report, which will provided during the review process.

Finally, if your agency is unable to participate at all and unable to review and provide a signature on the annual report by mid-September, please reply to this email indicating this so that this may be documented.
